



CWLP’s mySolar program allows customers to go green by purchasing locally generated solar power as an add-on to electric bill via subscription. This 250 kW solar installation is located adjacent to the utility’s Washington Substation at 606 Old Tippecanoe Drive. MySolar provides an affordable option for solar energy for those who want to go green, but without the financial means or space to install their own solar.

Monthly Cost	\$4.40 per 100 kWh Block
Setup Fee	A one-time \$5 fee will be included in the first month's mySolar subscription billing.
Term	1 year, with automatic renewal

CWLP mySolar Subscription Rate Rider

Program Terms and Conditions

Eligible Customers	Are directly metered residential or commercial electric customers of CWLP who fall under Residential Rate 30, 31, 32, 33, 34, 35, 36, or 37 or Commercial Rate 40, 41, 42, 43, 44, 46, 47, 58, 71, or 73 with no account past due more than 33 days.
Prices, Fees, and Charges	The initial subscription rate is \$4.40 per 100 kilowatt-hour (kWh) block. A onetime subscription setup fee of \$5.00 will be included in the first months bill. Every June 1st, the Chief Utility Engineer has authority to adjust the 100 kWh block rate up or down based on current and expected capital costs of CWLP owned and operated solar generation. Notice of a rate adjustment under the this rider shall be provided to all subscribers at least 30 days prior to implementation. Subscribers will have options to opt out of service under this rider prior to implementation of an increase.
Agreement Terms	Customers electing to purchase renewable energy under this rider shall remain on this rider for a minimum of 1 year or until notice is received of an increase in rate.
Subscription and Transferability	Customers choosing to subscribe to Rider A are purchasing renewable energy from a CWLP owned renewable generating facility. Renewable Energy Credits (RECs) associated with a CWLP owned renewable generation facility will be retained by CWLP and may be sold at the discretion of the Chief Utility Engineer. Customers that relocate within the CWLP electric service territory can transfer their subscription to the mySolar program at no charge. Customers that move to a location outside of CWLP electric service territory shall surrender their mySolar subscription to CWLP for future customers.
Availability	The utility may discontinue accepting new applications for service under this rider at any time customer demand exceeds CWLP owned renewable energy generating capacity. The utility may discontinue existing subscriptions under this rider in the event CWLP owned and operated solar generation is no longer available.
